  - Te shi keshi “Galamsey” nitsumɔ ni esaaa le.
- IV. Ye 2018 Shika Gbejianotoo le mli le, ketso “National Entrepreneurship Innovation Programme” (NEIP) nɔ le abaadu nitsumɔtsemɔ mumɔ awo Ghana oblahii ke yei ni eye afii ni shɛɛ 35 le amlɔ. Wɔbaakwe nitsumɔi ke nitsumɔhei, okwaa ke ehe nifeemɔi, nitsumɔtsemɔi ke ehɛtsakemɔ ni he hiaa koni wɔke shika awo mli. 1. Maŋ Shika gbejianotoo ji gbɛi anɔ ni Amralofoi tsɔɔ kɛnaa shika kɛ bɔ ni eke shika le baatsu nii eha. Ye Ghana le, awo mla ake Maŋsɔɔɔ ni Kwɛ Shika Gbejianotoo Nɔ le adamɔ Maŋhiɛnyisɔ le najiaŋ koni eke shika gbejianotoo le ayafɔ Mlawoo Kpee le hiɛ daa afi. Maŋ Shika Gbejianotoo le efee afi kome nɔ, ni ajeɔ shishi kejeɔ Aharabata 1 keyashio Afuabe 31. Atsɛɔ be nɛ Shikakuramɔ Afi.
2. 2018 Shika Gbejianotoo le damɔ Jenjeŋ Ekomefeemɔ Kuu (UN) le kraŋmɔ keha jakui Anɔyaa Nifeemɔ Ni Baanye Adamɔ Amenane Nɔ (Sustainable Development Goals) SDG ye nitsumɔ srɔtoi amlɛ le nɔ. Ye Gbo 25, 2015 gbi le nɔ le jenjeŋ jakui fɛɛ ma naa shi ake amɛbaadi gbejianotoo ko sɛɛ kebaa planɛti le yi, akɛtee maŋbii fɛɛ anɔyaa shi, akɛwo toinjoɔɔnamɔ kɛ mɛi atɛŋ tsakpaa nɔ keha nɔyaa ni baanye adamɔ enane nɔ.



**Tɛŋmɔ 2: 2018 Shika ni abaana le Mlitsɔmɔ**





Shika ni afite fee ke nyoji ni ahie kebashi Gbo 2017 nyoo le no le naa yakpa GH¢37,705.00 miliyo. Ene yafee GDP oha mlijaa 18.7 (18.7%) tsebele bojeti le fo shika ni naa sheo GH¢41,036.20 miliyo. Ye 2018 mli le aakpa gbe ake abaafite shika ni naa sheo GH¢62,010.30. Ene baafee GDP le mli oha mlijaa 25.7 (25.7%).

- 17. Ayose ake Shika fee ni abaana ke Kee Shika ni naa baashe GH¢51,039.10 miliyo le faaa bo ni abaanye akewo nitsumoi le fee ahe nyoji ni naa baashe GH¢62,010.13 le. 

### **Srawahewalε kε muŋmɔŋ**

23. Koni anyε ana nɔmimaa akε mei baanyε awo srawa hewalε he nyɔmɔ, ana hienɔkamɔ ye srawa hewalε nɔ, ni ana bɔ ni sa akε eyɔ ye SDG kpawo (7) lε mli lε, Amralofoi to gbejianɔ nεε ye 2017 mli:

- Akε 445 MW hewalε tsɔne bafata nɔ ni Jaku maŋ lε yɔɔ momo lε he, kεwo hewalε ni anaa lε nɔ kεje 4,132 MW kεtee 4,577 MW ye 2017;
