1.0 OVERVIEW

Established under Section 20 of the Public Procurement Act, 2003 (Act 663), the Central Tender Review Board (CTRB), now the Central Tender Review Committee (CTRC) is mandated to ensure compliance with the provisions of the Public Procurement Act by Procurement Entities.

1.1 Performance for the Third Quarter 2021

Within the period (July – September 2021), the CTRC considered evaluation reports submitted by the procurement entities as detailed in the tables and charts below.

The 3rd Quarter Report differentiates between submitted and reviewed evaluation reports. Submitted evaluation reports are those delivered by procurement entities to the CTRC Secretariat. The reviewed evaluation reports on the other hand are the Committee assessed evaluation reports. During the 2021 third (3rd) quarter review, the Secretariat received one hundred and thirty-six (136) submitted evaluation reports. Of this total, procurement of goods (supplies) represented 59%, an 8% increase from the previous quarter's (2021 second quarter) supplies (goods). Procurement of services represented 16%, a decrease of 8% compared to the previous quarter. Similarly, the procurement of works amounted to 25% of the total submissions made, representing a 1% increase from the previous quarter.




Figure 1.1.1 Submission by Type of Procurement

The procurement of goods recorded the highest increase from the previous quarter. This increase in submissions is attributed to the high number (15) of procurement submissions made by the Ministry of Health in response to the Ministry of Health's Coronavirus (COVID-19) emergency preparedness response plan. The number of submissions (15) made by the Ministry of Health on goods represents 16% of the total submissions made on goods in the third quarter.





Figure 1.1.2 Submissions by Method of Procurement.

Figure 1.1.2 summarizes the procurements made in the third quarter of 2021 by the methods of procurement. From the figure above, the method with the highest frequency during the third quarter is the NCT (36%), followed by the RT (32%), then SS (14%), with variation/addendum, RFP/QOI/QCBS, CQ taking up 7%, 5%, 2%, respectively. While the least used methods are ICT (1%) and RFQ (1%).




Figure 1.1.3 summarizes the procurements made in the third quarter of 2021 by the main Sectors. Sixty-Four (64) entities submitted various procurements for approval. Ten (10) from the Administrative Sector, fifteen (15) from the Economic Sector, eight (8) from the Infrastructure Sector, twenty-six (26) from the Social Sector and five (5) from the Public Safety Sector. From the figure above, the Sector with the highest procurements is the Social Sector.

Within the Social sector, the Ministry of Health recorded the highest submission frequency totalling fifteen (15), which is equivalent to 11%. Of the total submissions made by the Ministry of Health, eleven (11) were looked at under emergency meetings while four (4) were reviewed during regular meetings. The high number of submissions looked at during the Emergency sittings for the Ministry of Health were on the supply of goods for the Entity's COVID-19 Emergency Response Plan. The second highest procurements are from the University of Cape Coast (UCC) with a total of seven (7) procurements. All of the referenced submissions were reviewed during regular meetings.

The second highest number of procurements by sectors is the Economic Sector with forty-two (42) submissions. The entities with the highest submissions in the Economic Sector are Ghana National Petroleum Corporation (GNPC) with five (5) submissions reviewed during regular meetings and Minerals Commission with five (5) submissions. Three (3) of the submissions were looked at during emergency meetings and two (2) were looked at during regular Meetings).

The Sector to record the third (3rd) highest number of submissions is the Administrative Sector. Within the Sector, the Ministry of Local Government, Decentralization and Rural Development (MLGDRD) recorded the highest number of procurement submissions totalling three (3), which were looked at during regular Sittings.


The sector to record the fourth (4th) highest number of submissions is the Infrastructure Sector. Within the sector, Ghana Water Company Limited (GWCL) recorded the highest number of two (2) submissions with the remaining entities recording one (1) submission.

The sector to record the least number of procurement submissions within the third (3rd) quarter is the Public Safety Sector. The Judicial Service is the entity to have recorded the highest number (3) of procurement submissions within the third (3rd) quarter of 2021 within the Public Safety sector.

Of the one hundred and thirty-six (136) evaluation reports received during the period, forty-six (46) under goods were approved. Thirty-Four (34) received under goods were denied approval. Of the Forty-Six (46) that were approved, thirty-six (36) were granted approval during regular meetings whereas ten (10) were granted approval during emergency meetings. Of the thirty-four (34) denied approval, twenty-six (26) were during the Committee's regular meetings and eight (8) were during emergency meetings.

Subsequently, of the twenty-two (22) procurement submissions received under services, six (6) were granted concurrent approval while fifteen (15) were denied (including 1 not granted approval during an emergency meeting).


Again, the approved procurement submissions under works add up to sixteen (16) (12 approved during regular meetings and 4 approved during emergency meetings) while eighteen (18) were not granted concurrent approval (10 during regular meetings and 8 during emergency meetings).

From figure 1.2.2, it is evident that of the one hundred and five (105) procurement submissions that were reviewed during the regular meetings, fifty-four (54) of them were given outright approvals whereas fifty-one (51) of them were asked to address the issues raised during the meetings. No submission was however, denied approval. Of the thirty-one (31) procurement

submissions that were reviewed during the emergency meetings, fourteen (14) were granted approval whereas seventeen (17) of them were not granted concurrent approval. No procurement submission was however, denied approval.

In summary, sixty (68) of the submissions reviewed, representing 50% received outright approvals. On the other hand, sixty (68) of the reviewed submissions, representing 50% had issues that need re-examination and re-submission by the procurement entities.




Figure 1.3 Graphical Representation of approved amount.

From figure 1.3, the highest approved amount is five hundred and eighty-eight million, four hundred and thirteen thousand, two hundred and seventy-five Ghana Cedis and sixty-six pesewas (GH¢588,413,275.66) generated from responses reviewed in the previous quarters. The least amount, thirty million, eight hundred and sixty-four thousand, three hundred and thirty-eight Ghana Cedis (GH¢30,864,338.00) was approved during the 103rd regular sitting. The one hundred and twenty-six (126) procurement submissions that were given approval during the regular and emergency sittings as well as responses from previous quarters amounted to one billion, seven hundred and ninety-one million, one hundred and thirty-six thousand, nine hundred and eighty-eight Ghana Cedis, ten pesewas (GH¢1,791,136,988.10) for the period under review. This amount resulted from the satisfactory review of fifty-four (54) new procurement submissions during the regular sittings, fourteen (14) new procurement submissions during the emergency sittings and fifty-eight (58) responses from the previous quarters.

The most frequent issues and observations raised by the CTRC for further clarification by the procurement entities included the following:

- No documentary evidence provided on advertisement of method of procurement.
- No documentary evidence provided to justify the basis for the disqualification of tenderers and the invitation of tenderers.
- No procurement plan posted on the Public Procurement Authority's website.
- No price reasonableness analysis was carried out to assure value for money.
- No information provided to demonstrate availability of funding for the Procurement.

To enhance the Committee's review, procurement entities were to consider the following:

- ➤ Provide all the necessary documentation required by the CTRC to minimize referrals, which invariably lead to unnecessary delays in the procurement progress.
- > Adhere strictly to the provisions of the Procurement Acts to overcome approval challenges.
- Adhere strictly to evaluation criteria pre-disclosed in tender documents.
