### 1.0 OVERVIEW

Established under Section 20 of the Public Procurement Act, 2003 (Act 663), the Central Tender Review Board (CTRB), now the Central Tender Review Committee (CTRC) is facilitate mandated to ensure compliance with the provisions of the Public Procurement Act by Procurement Entities.

# 1.1 Performance for the Third Quarter 2022

Within the period under review (July – September 2022), the CTRC considered evaluation reports submitted by the Procurement Entities as detailed in the tables and charts below.

The tables above are a representation of all the submissions received from the various Entities during the period under review. The submissions are classified into the three types of procurements (Goods, Services, and Works). During the 3<sup>rd</sup> Quarter of 2022, the Committee received a total of one hundred and eight (108) evaluation reports. Of this total, procurement of Goods (Supplies), totalling seventy-four (74), represented 68.5% of the total procurements made within the period. Procurement of Services, totalling twelve (12), represented 11.1%, and procurement of Works, totalling twenty-two (22), represented 20.4%.




Figure 1.1 Submission by Procurement Type

The September recorded the highest submissions (55) for review. Forty-eight (48) submissions were reviewed during the Regular Sittings of the Committee representing 87.3% and the remaining seven (7) were submitted for emergency and represented 12.7%. The overall submissions in the 3<sup>rd</sup> quarter per the procurement type is summarised in Figure 1.1 below.




Figure 1.2: Submissions by Procurement Method, 3rd Quarter, 2022.

Figure 1.2 summarizes the procurement submissions in the 3<sup>rd</sup> quarter of 2022 by procurement method. The method with the highest frequency during the quarter was National Competitive Tendering (NCT) (60.2%), followed by the Restrictive Tendering (RT) (19.4%), variation/addendum (6.5%), International Competitive Tendering (ICT) (3.7%), with shopping, Expression of Interest/Request for Proposal/ Quality and Cost Based Selection (RFP/QOI/QCBS), Sole Sourcing (SS), Price Quotation (PQ) and Consultant's Qualification (CQ) Information taking up 2.8%, 1.9%, 1.9%, 1.9% and 1.9%, respectively.




Figure 1.3: Graphical Representation of Submission by Sector of Procurement

Figure 1.3 summarizes the procurement submissions in the 3<sup>rd</sup> quarter of 2022 by sectors. Fifty-four (54) entities submitted review requests: ten (10) from the Administrative Sector; fifteen (15) from the Economic Sector; seven (7) from the Infrastructure Sector; one (1) from the Public Safety Sector; and twenty-one (21) from the Social Sector. From the figure above, the sector with the highest number of procurement submissions was the Social Sector with 21 submissions making up 38.9% of the new submissions.

At the end of the 3<sup>rd</sup> quarter, 27.8% of the reviewed submissions were from the Social Sector, 35.2% were from the Economic Sector, 15.7% from the Infrastructure Sector, 19% from the Administrative Sector, and 0.9% from the Public Safety Sector.

Of the one hundred and eight (108) evaluation reports received during the period, forty-seven (47) submissions under Goods were approved, twenty-six (26) received under Goods had issues to address and/or clarify, hence not granted concurrent approval, and the Committee advised that the approval of one submission, "Procurement of Various Reciprocating Compressors (Phase 1) – modification" be done under the mandate of the ETC of GNGCL in accordance with its approval threshold.

Of the twelve (12) procurement submissions received under Services, five (5) were granted concurrent approval, five (5) had issues to address and/or clarify and the committee was unable to grant approval for "Set-Up of Omni/Multi Channel Contract Centre" submission from GRA. This was due to the evaluation criteria emphasising on 5-year period of demonstrable experience (75 marks) with the remaining 25 marks allocated to qualification of key staff. The criteria were deemed skewed and unbalanced, under a Restricted Tendering. Also, two of the shortlisted and approved firms failed to participate in the tender, resulting in less competition.

For works, the approved procurement submissions totalled ten (10), while ten (10) had issues to address and/or clarify. The Committee advised that the

approval of one submission, "Construction of Regional Audit Office in Kumasi – variation" from the Audit Service be considered by the ETC since the amount in Variation is less than 10% of the original contract sum. Also due to the fact that project review and value engineering was done outside project budget/contract amount, it was deemed inappropriate and therefore unacceptable for the submission of "Construction of 4-storey multi-purpose building at Sunyani – Variation". Hence the Committee was unable to grant approval.




Figure 1.5: Graphical Representation of approved amount in Gh¢ mn.

From Figure 1.5, the highest approved amount was One billion, six hundred and Thirty-four million, Eighty-nine thousand, eight hundred and Seventy-three Ghana Cedis and thirty-one pesewas (GH¢1,634,089,873.31) generated from thirty-nine responses (Submissions that were not given approval in previous quarters). This figure has University of Ghana taking up about 55% of the total value of responses (Design and supply of paraphernalia for congregation (certificate folder - 50,000 pieces), medallions (various) - 5,000 pieces) and awarded at GH¢903,037,000.00. The least value of responses was Twenty million, Fifty-two thousand, Eight hundred and Sixty-two Ghana Cedis and Fifteen pesewas (GH¢20,052,862.15). The project was approved during the 17th Regular Sitting of the Committee in the 3rd Quarter.

At the end of the 3<sup>rd</sup> Quarter, approved amount from responses in previous quarters made up about 65% of the total approved for the 3<sup>rd</sup> quarter while 29% and 6.7% were from regular and emergency sittings, respectively. The one hundred and forty-seven (147) procurement submissions that were given approval during the regular meetings, as well as responses from previous quarters, amount in value to about GH¢2.5 billion for the period under review. This amount resulted from the satisfactory review of one hundred and eight

(108) new procurement submissions during the Regular and Emergency Meetings, and thirty-nine (39) responses to submissions that were not granted approval in the previous quarters.




Figure 1.6: Graphical Representation of approved amount by type of procurement.

From Figure 1.6, at the end of the 3<sup>rd</sup> Quarter, procurement made under Goods amounted to about GH¢1.43 billion, representing about 57% of all reviewed submissions in the period under review. Procurement made under Services amounted to GH¢46.2 million, representing about 2% of all reviewed submissions in the period under review. Procurement made under Works

amounted to GH\$1.0 billion, representing about 41% of all reviewed submissions in the period under review.

### 3.0 ISSUES AND OBSERVATIONS RAISED BY THE CTRC

The common issues and observations frequently raised by the CTRC for further clarification and/or redress by the procurement entities are in three categories of technical, financial, and documentation as presented below:

#### Technical

- No remarks made on the basis for acceptance of specifications that fall short of strict compliance to minimum specification thresholds.
- No justified grounds for disqualification of tenderers.
- Tender validity period has expired.
- Wide differences in scoring by Evaluators, suggest the use of subjective sub-criteria for evaluation.
- No benchmark unit rates provided to justify the acceptance of some revised rates by the contractor.
- Provisional sums and contingencies constituting recommended award suggest inadequate design preparations.
- Firms indicated to have failed and declared non-responsive are however evaluated in detail on price and post qualification of contract award recommendation.
- No assurance of authenticity of the offered Vehicles as Manufacturer's Authorization was not a tender requirement.
- Failure of Firms to meet requirement of Annual Turnover.

### **Financial**

- No benchmark unit rates provided to justify the use of rates for the computation of Variation Works.
- Confirm availability and adequacy of funding for the Variation Works.
- No price reasonable analysis done to justify market price competitiveness of recommended award amount.
- Inconsistency in currency quoting in read-price offers and recommendation price.
- Total Read-out tender prices recorded for the two competing Firms are inconsistent with the Sum total of tender prices by the Firms.
- Contravention of the limit of 15% advanced Payment under Regulation 113 of the Public Financial Management Regulation, 2019, LI 2378.

### **Documentation**

- Conflicting tender opening dates on different pages of evaluation report.
- Long delayed submission of Variation application.
- Award recommendation wrongly captured in figures in evaluation report.
- No minutes of tender opening attached to the evaluation report.
- Failure of all evaluation Panel members to sign the evaluation report.
- Need for Entity to submit approval letter for the purchase of the Vehicles from the Office of the Chief of Staff, in view of recent directives by the Minister of Finance.
- Conflicting number of Firms, indicated to have purchased tender documents.

- Failure of Entity to publish advertisement of procurement on the PPA website.
- No documentary evidence provided on adequacy and availability of funding for the Project.
- Wrong capture of procurement method and conflicting approval date in evaluation report.
- No documentary evidence provided to confirm grounds used for disqualification of tenderers.
- No documentary evidence provided on signed public records of Tender Opening to authenticate the offer prices used for the evaluation of tender

### A1 Profile

Since its inauguration on 17<sup>th</sup> June, 2005, the Central Tender Review Board (CTRB), now Central Tender Review Committee (CTRC), has continuously exercised the highest standards of transparency, disclosure, integrity, and best practice, in line with its mandate to ensure compliance with the provisions of the Public Procurement Act, 2003 (Act 663) as amended, within the established authorised thresholds

The role of the CTRC is clearly expressed in the Public Procurement Act, 2003 (Act 663), and Amendment Act 914 (Section 20F). The 9-member Committee has the following mandated functions:

- a. To, in relation to a particular procurement under consideration, review the activities at each step of the procurement cycle leading to the selection of the lowest evaluated Tender, best offer, by the Procurement Entity in order to ensure compliance with the Provisions of the Act and its operating instructions and guidelines;
- b. Subject to (a), give concurrent approval or otherwise to enable the Procurement Entity to continue with the Procurement Process;
- c. Furnish the Procurement Board with reports in a prescribed format;
- d. Participate in Public Procurement Fora;
- e. Review decisions of Heads of Entities in respect of a compliant; and
- f. Engage the services of such Consultants and Advisors or co-opt persons with specialised expertise, as may be required for the proper and efficient discharge of its functions.

### A2 Our Values
