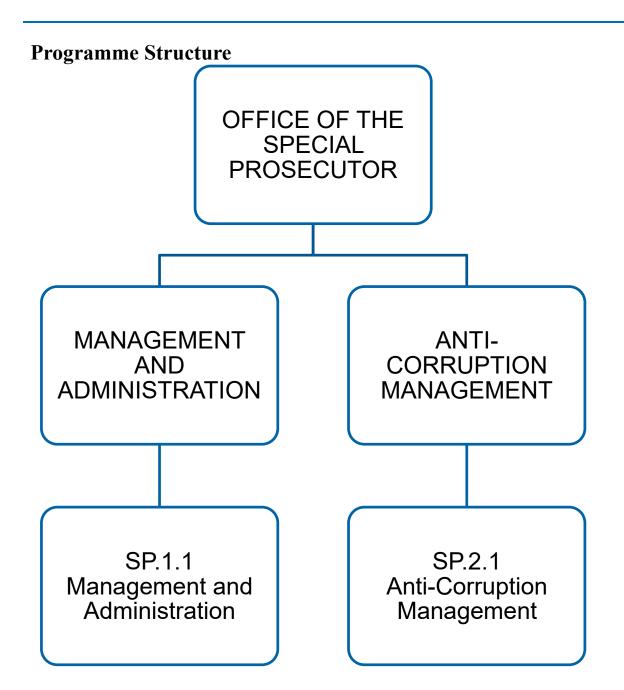

PART A: STRATEGIC OVERVIEW OF THE OFFICE OF THE SPECIAL PROSECUTOR

1. POLICY OBJECTIVES

The NMTDPF contains one Policy Objective relevant to the Office of The Special Prosecutor. This is:

• Promote the fight against corruption and corruption-related offences, and such existing offences under enactments arising out of or consequent to corruption and public procurement offences

2. VISION

Rendering corruption costly and unattractive in all its forms in the public and private sectors through sustained repression and suppression.

3. MISSION

Investigating and prosecuting specific cases of alleged or suspected corruption and corruption-related offences; recovering the proceeds of corruption and corruptionrelated offences; and taking steps to prevent corruption.

4. CORE FUNCTIONS

The core functions of the Office include the following:

- the investigation and prosecution of cases of alleged or suspected corruption and corruption related offences under the Public Procurement Act, 2003 (Act 663);
- investigation and prosecution of cases of alleged corruption and corruption related offences under the Criminal and Other Offences Act, 1960 (Act 29) involving public officers, politically exposed persons and persons in the private sector involved in the commission of the offence;
- investigation and prosecution of cases of alleged or suspected corruption and corruption related offences involving public officers, politically exposed persons and persons in the private sector involved in the commission of the offence under any other relevant law;
- recover and manage the proceeds of corruption;
- disseminate information gathered in the course of investigation to competent authorities and other persons the Office considers appropriate in connection with the offences specified in paragraphs (a) and (b);
- co-operate and coordinate with competent authorities and other relevant local and international agencies in furtherance of this Act;



- receive and investigate complaints from a person on a matter that involves or may involve corruption and corruption-related offences;
- receive and act on referrals of investigations of alleged corruption and corruption related offences by Parliament, the Auditor-General's Office, the Commission on Human Rights and Administrative Justice, the Economic and Organized Crime Office and any other public body; and
- perform any other functions connected with the objects of the Office.

6. EXPENDITURE TRENDS FOR THE MEDIUM-TERM.

The OSP was allocated GHC129,549,380.00 in 2023. This is made up of GHC68,900,000.00 for Compensation of Employees, GHC34,279,380.00 for Goods and Services and GHC26,370,000.00 for Capital Expenditure. In addition to the budgetary allocations the office received extra budgetary support of GHC37,500,000.00 for Goods and Services and GHC25,000,000.00 for Capital expenditure within the period under review. The releases were to speed up the operationalization of the office.



Budget performance for the year under review as at 31st October, 2023 is summarized in the table below:

During the period, the Office requested for an additional budget support of GHC125,000,000.00 of which Ghcephicologo 62,500,000.00 was allocated. This has since been released and spent.

7. ACHIEVEMENTS IN 2023

Recruitment

The Office has achieved a significant milestone by successfully concluding a major recruitment effort, bringing on board 249 personnel for its initial establishment. This achievement marks the Office's strongest position since its inception in 2018, as it remains steadfast in its mission to combat corruption and corruption-related offenses. The primary objective is to prevent corruption and, when necessary, investigate and prosecute such cases, as well as recover illicit gains from these activities.

Investigations and Prosecutions

Starting from August 2021, the Office has initiated legal proceedings against seven individuals, including a former minister, a CEO and two deputies, a district chief executive nominee, public servants, and private individuals, who stand accused of various corruption and corruption-related charges. These cases are currently at various stages of trial at the High Court sitting in Greater Accra, Kumasi, and Tamale.

The Office has also received more than 180 petitions alleging corruption and related offenses. Independently, the Office has launched several investigations, each progressing through different stages.

Notably, the Office has completed its investigation into a case referred by the President of the Republic, concerning suspected corruption and corruption-related offenses involving a former Minister of State at the Ministry of Finance. These allegations stemmed from an investigative documentary titled "Galamsey Economy," published by Tiger Eye P.I. and the investigative journalist, Anas Aremeyaw Anas.

Additionally, the Office has wrapped up its investigation into allegations of an attempt by an unnamed wealthy businessman to bribe members of the majority caucus of Parliament. The Office extends its appreciation to the Rt. Hon. Speaker of Parliament and his team for their cooperation and support during this investigation.



The Office has also concluded an investigation into suspected corruption and corruption-related offenses related to the procurement and contract awarded to Turfsport Ghana Limited by the Gaming Commission of Ghana.

Furthermore, the Office has concluded an investigation into allegations of the misuse of public office for personal gain involving the former Secretary of the erstwhile Inter-Ministerial Committee on Illegal Mining (IMCIM). This investigation is part of a broader inquiry into illegal mining and the activities of the IMCIM.

The Special Prosecutor will issue directives and take further action on these completed investigations in due course.

Collaboration

The Office maintains an active and ongoing collaboration with various law enforcement agencies, as well as civil society, non-governmental organizations, and community-based groups dedicated to combating corruption.

Currently, the Office is engaged in a collaborative effort with the Federal Bureau of Investigation (FBI) in several cases. This collaboration seeks to ascertain the legality of the wealth of suspects, examining the movement of funds between Ghana and the United States.

The Office continues to engage in informative discussions and meetings with foreign and diplomatic missions, as well as international organizations. These include missions from the United States, United Kingdom, European Union, and the United Nations Office on Drugs and Crime (UNODC), among others. The World Bank, the IMF, the International Anti-Corruption Coordination Centre (IACCC), and the International Narcotics and Law Enforcement Affairs of the United States (INL) have generously donated computers to support our Call & Complaints Centre in its operations.
